Fee Policies:

LIA will waive the consultation fee for people living in homeless or domestic violence shelters at the time of service.

LIA offers payment plans (ask for details), but will not submit the application until the service fee is **paid in full**.

Penalty Fees:

LIA Staff Members' time is valuable. LIA serves hundreds of families each year. Please be respectful of your attorneys time. If you have an appointment scheduled, please arrive prepared and on time.

If you are unable to make your appointment or you are not prepared, **call to cancel**. Failure to call and cancel will result in a \$40 fee added to your account. If you miss two or more appointments without calling in advance, your case will be automatically closed with our office. Failure to arrive at your appointment prepared with all documents and information will result in a \$40 fee added to your account.

This policy is strictly enforced.
